AN ORDINANCE TO APPROVE **DOCKET Z-2018-019**, PETITION OF CPH HOLDINGS LLC FOR A CONDITIONAL USE PERMIT TO OPERATE A LIGHT MANUFACTURING METAL SHOP FOR THE FOLLOWING DESCRIBED PROPERTY: LOT 1C ST. CLAUDE HEIGHT SUBDIVISION. PROPERTY LOCATION: 1231 CENTER ST. ARABI, LA 70032.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. The St. Bernard Parish Council does hereby approve **Docket Z-2018-019**, petition of CPH Holdings LLC for a conditional use permit to operate a light manufacturing metal shop for the following described property: Lot 1c St. Claude Height Subdivision.

Property Location: 1231 CENTER ST. ARABI, LA 70032.

Planning Commission recommends **APPROVAL** with the following **CONDITIONS**:

CONDITIONS:

1. Shall be located within unit (bay) closest to St. Bernard Hwy. Not more than one (1) unit for the entire structure.
2. Mesh screen located on the existing perimeter fencing.
3. One (1) commercial dumpster pen area.

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:




