AN ORDINANCE TO DECLARE THE VEHICLES ON THE ATTACHED EXHIBIT "A" AS SURPLUS AND TO AUTHORIZE THE PARISH PRESIDENT OR HIS DESIGNEE TO EXECUTE ALL NECESSARY DOCUMENTS TO TRANSFER SAID VEHICLES.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

WHEREAS, the Parish considers the vehicles listed on the attached Exhibit "A" as surplus and these properties are not needed for a public purpose; and,

WHEREAS, the Parish intends to transfer these vehicles in compliance with state law.

SECTION 1. The properties on the attached Exhibit "A" are hereby declared surplus and are not needed for any public purpose.

SECTION 2. The President of St. Bernard Parish or his designee is hereby authorized to execute any documents necessary to transfer the vehicles listed on the attached Exhibit "A" in compliance with state law.

SECTION 3. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

The above and foregoing having been submitted to a vote, the vote there upon resulted as follows:


