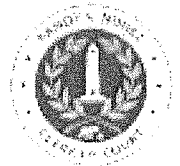

RECITALS

WHEREAS, both parties hereto further desire to extend the contract as stated below.


EXTENSION/AMENDMENT
