AMENDMENT NO 1
TO AGREEMENT
BETWEEN
OWNER AND ENGINEER
FOR PROFESSIONAL DESIGN SERVICES

This is an Amendment No.1 attached to and made part of the Agreement dated August 1, 2014, between St. Bernard Parish (OWNER) and H. Davis Cole & Associates, LLC (ENGINEER) for professional services.

The August 1, 2014 Agreement is hereby amended as follows:

1. Under Exhibit A amend Paragraph 4.0 to read as follows:

4.0 – Method of Payment

The current amount of funding available to the OWNER is \$1,000,000. The parties acknowledge that the total cost to complete the total Scope of Services has not been established at this time but will exceed the current funding. OWNER agrees to pay for Services rendered by ENGINEER up to the amount \$1,000,000, based upon the hourly rate fee schedule provided below. Project costs shall not exceed funded amount without an amendment to this Agreement; provided that the parties agree that this Agreement shall be amended as funding becomes available to complete the Scope of Services and the work covered by the Scope of Services contained within this Agreement shall not be subject to a re-procurement process.


