This is an Amendment No.6 attached to and made part of the Agreement dated July 24, 2014, between St. Bernard Parish (OWNER) and BCG Engineering & Consulting, Inc. (ENGINEER) for professional services.



The July 24, 2014 Agreement is hereby amended as follows:

1. Under Exhibit A amend Paragraph 4.0 to read as follows:

4.0 – Method of Payment

The current amount of funding available to the OWNER for work on Tasks 1 through 6 is \$3,400,000; the parties acknowledge that the total cost to complete Tasks 1-6 has not been established at this time but will exceed the current funding. OWNER agrees to pay for Services rendered by ENGINEER for Tasks 1 through 6, up to the amount \$3,400,000, based upon the hourly rate fee schedule provided below. Project costs shall not exceed funded amount without an amendment to this Agreement; provided that the parties agree that this Agreement shall be amended as funding becomes available to complete Tasks 1-6 and the work covered by Tasks 1-6 of this Agreement shall not be subject to a re-procurement process.
