On motion of Mr. Montelongo, seconded by Mr. Lewis, it was moved to adopt the following ordinance:

## **ORDINANCE SBPC #1479-02-14**

### **Summary No. 3041**

AN ORDINANCE TO RETAIN FRANCIS B. MUHALL, ESQ. AS LEGAL COUNSEL TO REPRESENT ST. BERNARD PARISH IN E.E.O.C. CHARGE NO. 461-2014-00467 AND ANY LITIGATION RELATED THERETO.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. The St. Bernard Parish Council, the Governing Authority, does hereby approve and authorize the employment of Francis B. Muhall, esq. to represent St. Bernard Parish Government in E.E.O.C. Charge No. 461-2014-00467 and any litigation related thereto.

SECTION 2. Salary. The compensation shall be at rates not to exceed the fee schedule from the Louisiana Attorney General.

SECTION 3. Effective Date. This ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto this ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 4. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion of this ordinance with the invalid portions omitted.

SECTION 5. The Parish President is hereby authorized to enter into a contract for legal services as provided in the attached contract and in accordance with section 4-02 (b) of the St. Bernard Parish Home Rule Charter. Said contract is attached hereto as Attachment "A" and includes the special handling and reporting instructions policy.




