AN ORDINANCE TO AMEND CHAPTER 22, ZONING; SECTION 22-6-7, C-2 GENERAL COMMERCIAL DISTRICT; SUBSECTION 22-6-7.1 TRUCK STOPS BY CREATING AND ADDING SUB-SECTION 22-6-7.1 (17), TO THE ST. BERNARD PARISH CODE OF ORDINANCES.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. That St. Bernard Parish Council does hereby Amend Chapter 22, Zoning; Section 22-6-7, C-2 General Commercial District; Subsection 22-6-7.1, Truck Stops by creating and adding Sub-Section 22-6-7.1 (17), to the St. Bernard Parish Code of Ordinances as attached in "Exhibit A".

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President and the adoption of the new FEMA flood insurance rate maps by the governing authority. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted

Sec. 22-6 Commercial and industrial zoning districts

22-6-7 C-2 General Commercial District

22-6-7.1 Truck stops

- (17) The provisions of this subsection 22-6-7 shall not apply to any business or any building or land used for such business, or to changes in ownership in such business, building or land, that was licensed prior to the adoption of this subsection.
