AN ORDINANCE AUTHORIZING THE PARISH PRESIDENT TO PURCHASE CERTAIN PROPERTIES UNDER THE SEVERE REPETITIVE LOSS PROGRAM.

**WHEREAS**, the St. Bernard Parish Council authorizes and approves the Parish President to purchase 1031 Center St., 2508, Citrus Ave., 2108 Plaza Dr., 2208 Plaza Dr., and 1617 Schnell Dr.;

**WHEREAS**, the properties shall be purchased under the federally funded Severe Repetitive Loss Program;

**WHEREAS**, the purpose of the Severe Repetitive Loss Program shall be "to provide funding to reduce or eliminate the long-term risk of flood damage to severe repetitive loss structures."
