On motion of Mr. Montelongo, seconded by Mr. Gorbaty, it was moved to adopt the following ordinance:

AN ORDINANCE TO DECLARE AS SURPLUS 3107 MARIETTA, WHICH HAS BEEN ADJUDICATED TO THE PARISH, AND TO AUTHORIZE THE SALE OF SAID PROPERTY TO CLYDINE AMIE FOR \$ 1000.00.

ST. BERNARD PARISH COUNCIL, THE GOVERNING AUTHORITY, DOES HEREBY FIND IT NECESSARY AND IN THE PUBLIC INTEREST TO ORDAIN:

Whereas, the property located at 3107 Marietta was adjudicated to the Parish on June 23, 2010.

Whereas, the Parish considers this property surplus and it is not needed for a public purpose.

Whereas, Clydine Amie has submitted an offer to purchase the property at a price set by the Parish Council and the Parish Council has determined she is the adjoining property owner that has maintained the property for more than one year.

SECTION 1. The following adjudicated property is surplus and is not needed for any public purpose:

3107 Marietta
Chalmette, Louisiana 70043
LOT 23 SQ. F Magnolia Sub 75 X 71 = 5325

This property will be referred to hereinafter in this ordinance as "3107 Marietta"

SECTION 2. It is determined that Clydine Amie is the adjoining owner that has maintained the property for more than one year.

SECTION 3. The President of St. Bernard Parish Government is hereby authorized to sell 3107 Marietta to Clydine Amie for the purchase price of \$1000.00, with Clydine Amie to pay any closing costs. The President is further authorized to execute all documents necessary to effectuate the sale in compliance with La.R.S. 47:2201 et seq., specifically, La.R.S. 47:2202B & La.R.S. 47:2206, as well as the St. Bernard Parish Adjudicated Surplus Properties Program (Ordinance SBPC# 1378-03-13) provided that Clydine Amie continues to maintain the property up until the date of the sale.

SECTION 4. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 5. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:


