BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, AUGUST 19, 2014 AT THREE O'CLOCK P.M.

On motion of Mr. Montelongo, seconded by Mr. Lewis, it was moved to **adopt** the following ordinance:

## **ORDINANCE SBPC #1541-08-14**

AN ORDINANCE TO AMEND CHAPTER 13, OCCUPATIONAL LICENSE, TAXES, AND REGULATIONS; ARTICLE III, ITINERANT MARKETS, MOBILE VENDORS, PEDDLERS, ETC; TO CREATE AND INSERT SEC. 13-44, PERMIT REQUIREMENTS FOR DISTRIBUTION AND SOLICITATION OF THE ST. BERNARD CODE OF ORDINANCES.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

**WHEREAS**, The Parish Council believes it to be in the best interest of the citizens of St. Bernard Parish and St. Bernard Parish Government to add Chapter 13 Article III Sec. 13-44 Distribution and Solicitation Prohibited.

**SECTION 1.** The St. Bernard Parish Council hereby adds the following definitions to Chapter 13 Article III Sec. 13-44 Permit Requirements for Distribution and Solicitation:

(a) Permits shall only be issued under the following criteria:

1. The department shall only issue a permit to groups, associations, fraternal orders, assemblies, congresses, corporations, juridical associations or formal associations of natural persons;
2. The purpose of the solicitation or distribution must be for a charitable, political, religious, altruistic, philanthropic or humanitarian reason;
3. Solicitors and distributors shall be the age of majority;
4. The procurer shall provide the full name, address of the organization and individual procuring the permit;
5. The procurer shall have a valid government issued ID.

6. The procurer shall identify all streets and intersections his organization wishes to conduct distributions or solicitations.
7. This permit may be issued by the Department of Community Development in accordance with Chapter 13, Article III, Section 34 of the St. Bernard

- (b) The permit shall be valid for thirty (30) days from issuance.
- (c) The permit shall cost fifty dollars and zero cents (\$50.00).

**SECTION 2. Effective Date.** This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

**SECTION 3. Severability.** If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:


