AN ORDINANCE DECLARING LOT 42A HOPEDALE SUBDIVISION AS SURPLUS, AND AUTHORIZING THE PARISH PRESIDENT TO EXECUTE ANY ACTS NECESSARY TO TRANSFER SAID PROPERTY.

ST BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. St. Bernard Parish Council, the governing authority for St. Bernard Parish, does hereby declare lot 42A Hopedale subdivision as surplus and authorizes the parish president to execute any and all acts necessary to transfer said property in accordance with the Louisiana Revised Statute 33:4711.

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.
