BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON WEDNESDAY, NOVEMBER 5, 2014 AT SEVEN O'CLOCK P.M.

On motion of Mr. Gorbaty, seconded by Mr. Lewis, it was moved to **adopt** the following ordinance:

## ORDINANCE SBPC #1580-11-14

AN ORDINANCE TO AMEND CHAPTER 2; ADMINISTRATION, ARTICLE I; IN GENERAL, SECTION 2-1; PARISH SEAL OF THE ST. BERNARD PARISH CODE OF ORDINANCES.

**WHEREAS**, the Parish Council believes it to be in the best interest of the citizens of St. Bernard Parish and St. Bernard Parish Government to amend Chapter 2, Article I Section 2-1 of the St. Bernard Parish Code of Ordinances.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

**SECTION 1.** The St. Bernard Parish Council does hereby amend Chapter 2, Article I Section 2-1 of the St. Bernard Parish Code of Ordinances to read as follows:

### 2-1. Prohibition

- A. There shall be a large blue disc containing the image of the Chalmette Monument in white the center surrounded by two crossed olive branches in gold, with each branch numbering 13 leaves. Below the crossed olive branches shall be pictured in and gold a field artillery piece with 6 cannon balls stacked in a pyramid form below the muzzle of the cannon. Surrounding the disc shall be a white ring with gold trim containing seven blue stars and the words "ST. BERNARD PARISH GOVERNMENT" capitalized in blue with gold borders. Outside the ring, there shall be a thin blue outer ring.

B. It shall be unlawful for any person to affix or use a facsimile of the parish seal or parish emblem on any document, sign, advertisement or equipment for personal or commercial use or in such a manner as to give the impression that the Parish of St. Bernard sanctions, sponsors, endorses or supports such person or activity or that such person is in any way affiliated with the Parish of St. Bernard, its agencies or districts; such unauthorized use of the parish seal and parish emblem shall also include any facsimile so similar in appearance as to confuse, tend to confuse, or not be clearly distinguishable from the official parish seal or parish emblem.

C. Any person violating the provisions of this section shall be guilty of a misdemeanor, and subject to a fine of five hundred dollars (\$500.00), and/or imprisonment for a term not exceeding thirty (30) days, and/or community service not to exceed thirty-two (32) hours.

**SECTION 2. Effective Date.** This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

**SECTION 3. Severability.** If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.
