AN ORDINANCE CHANGING THE NAME OF THE "ST. BERNARD PARISH COURTHOUSE" TO THE "JACK F. ROWLEY COURTHOUSE."

**WHEREAS**, the Parish Council believes it to be in the best interest of the citizens of St. Bernard Parish and St. Bernard Parish Government to dedicate the name of the courthouse to Jack F. Rowley; and,

**WHEREAS**, Mr. Rowley was the longest serving District Attorney in the state of Louisiana; and,

**WHEREAS**, Mr. Rowley served the Parish of St. Bernard with distinction and honor for over 52 years.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

**SECTION 1.** The St. Bernard Parish Council, the governing authority for St. Bernard Parish, does hereby ordain and decree the former "ST. BERNARD PARISH COURTHOUSE" shall be renamed and hereinafter forever known as the "JACK F. ROWLEY COURTHOUSE."

**SECTION 2.** Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

**SECTION 3.** Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of

The above and foregoing having been submitted to a vote, the vote there upon resulted as follows:




