## **ORDINANCE SBPC #1599-01-15**

AN ORDINANCE AUTHORIZING THE PARISH PRESIDENT TO PURCHASE CERTAIN PROPERTIES UNDER THE HAZARD MITIGATION GRANT PROGRAM.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

**WHEREAS**, the St. Bernard Parish Council authorizes and approves the Parish President to purchase Lots 15,16, 19, 99, 163, and 164 of the Village Square subdivision; and,

**WHEREAS**, the properties shall be purchased under the federally funded Hazard Mitigation Grant Program.

**SECTION 1.** St. Bernard Parish Council the governing authority for St. Bernard parish does hereby authorize the parish president to acquire Lots 15,16, 19, 99, 163, and 164 of the Village Square subdivision, under the Hazard Mitigation Grant Program.

**SECTION 2.** The President of St. Bernard Parish Government is hereby authorized to execute any documents necessary to purchase Lots 15,16, 19, 99, 163, and 164 of the Village Square subdivision, in compliance with state law.

**SECTION 3.** Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

**SECTION 4.** Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.
