AN ORDINANCE TO AMEND CHAPTER 11, HEALTH AND SANITATION; ARTICLE I, IN GENERAL; SECTION 11-2, ENFORCEMENT OF GRASS CUTTING REQUIREMENTS; VIOLATIONS; PENALTIES OF THE ST. BERNARD PARISH CODE OF ORDINANCES.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

WHEREAS, The Parish Council believes it to be in the best interest of the citizens of St. Bernard Parish and St. Bernard Parish Government to amend Chapter 11, Health and Sanitation; Article I, In General; Section 11-2, Enforcement of grass cutting requirements; violations; penalties of the St. Bernard Parish Code of Ordinances.

SECTION 1. The amended sections of Chapter 11, Article I, In general shall read:

- (d) The notice shall contain the following:
- (1) A charge of the total amount listed on the St. Bernard Parish Government Department of Public Works Road Work Order. This charge includes the cost of materials used, employee labor cost and cost of equipment used for the compliance cut.
 - (2) An additional charge of \$300.00 shall be assessed for the cost of the inspection and administrative costs. Included in this charge will be the cost of mailings, filing, liens and publication of notification in the official journal.

- (i) The Bureau of Administrative Adjudication shall have jurisdiction to hear appeals for wrongful assessment of grass liens. The appellant shall follow the rules of appellate procedure as defined by the Hearing Officer.

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:




