AN ORDINANCE TO DECLARE THAT ST. BERNARD PARISH GOVERNMENT INTENDS TO ACQUIRE FULL OWNERSHIP OF 30 EAST CHALMETTE CIRCLE, WHICH HAS BEEN ADJUDICATED TO THE PARISH, AND TO AUTHORIZE THE PARISH PRESIDENT OR HIS DESIGNEE TO ISSUE AND RECORD THE NOTICES REQUIRED BY LAW TO ACQUIRE FULL OWNERSHIP OF THE SAID PROPERTY.

ST. BERNARD PARISH COUNCIL, THE GOVERNING AUTHORITY, DOES HEREBY FIND IT NECESSARY AND IN THE PUBLIC INTEREST TO ORDAIN:

WHEREAS, the property located at 30 East Chalmette Circle was adjudicated to the Parish on June 24, 2009.

WHEREAS, the property is needed for a public purpose.

WHEREAS, the Parish desires to acquire full ownership of 30 East Chalmette Circle as authorized by LA. R.S. 47:2236.

SECTION 1. The following adjudicated property is needed for a public purpose:
30 East Chalmette Circle

SECTION 2. It is hereby declared that St. Bernard Parish Government intends to acquire full ownership of 30 East Chalmette Circle.

SECTION 3. The President of St. Bernard Parish Government or his designee is hereby authorized to issue the notices required by LA. R.S 47:2236(C) and to file a notice in the conveyance records indicating that St. Bernard Parish Government has acquired full ownership of the property in compliance with LA. R.S. 47: 2236.

SECTION 4. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 5. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:
