EXTRACT OF THE OFFICIAL PROCEEDINGS OF THE COUNCIL OF THE PARISH OF ST. BERNARD, STATE OF LOUISIANA, TAKEN AT A REGULAR MEETING HELD IN THE COUNCIL CHAMBERS OF THE ST. BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, SEPTEMBER 15, 2015 AT THREE O'CLOCK P.M.

On motion of Mr. Lewis, seconded by Mr. Lauga, it was moved to **adopt** the following ordinance:

## **ORDINANCE SBPC #1683-09-15**

### **Summary No. 3277**

Introduced by: Councilman Lewis on 8/18/15

Public hearing held on 9/1/15

AN ORDINANCE TO ALLOCATE A TEN DOLLAR WATER RATE CREDIT TO ALL WATER AND SEWER CUSTOMERS DURING THE SIXTY DAY INTENSIFIED CHORINE TREATMENT.

**WHEREAS**, for the health and safety of the citizens St. Bernard Parish the water and sewer instituted a sixty day intensified chlorine treatment throughout the St. Bernard Parish water system;

**WHEREAS**, this intensified treatment has led to higher than normal amounts of chlorine throughout the system;

**WHEREAS**, these higher levels of chlorine have produced some discomfort and deviation from daily habits of the citizens of St. Bernard Parish;

**WHEREAS**, in recognition of the extra expenses and discomfort the intensified treatment brought this body shall provide a ten dollar credit to the citizens of St. Bernard Parish.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

**SECTION 1.** That St. Bernard Parish Council, the Governing Authority, does hereby grant a ten dollar (\$10.00) credit to all registered meters during the sixty day intensified chlorine treatment. The credit shall apply for each month of the treatment not to exceed a total of ten dollars per a registered meter per a month. Said credit shall be applied to the billing cycle of September and October or the earliest possible cycles as determined by the water and sewer department. In no circumstance shall the credit exceed twenty dollars total per a registered meter. Customers who do not maintain a registered meter during the length of the treatment and the continuing billing cycles shall not receive the credit.

**SECTION 2.** Effective Date. This ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto this ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

**SECTION 3.** Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion of this Ordinance with the invalid portions omitted.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:


