On motion of Mr. Lewis, seconded by Mr. Lauga, it was moved to **adopt** the following ordinance:

AN ORDINANCE TO AMEND CHAPTER 13; OCCUPATIONAL LICENSE, TAXES AND REGULATIONS, ARTICLE II; FAIRS, BAZAARS AND OUTDOOR SHOWS TO ADD SECTION 13-27; PERMIT REQUIREMENTS FOR OUTDOOR MUSIC EVENTS TO THE ST. BERNARD PARISH CODE OF ORDINANCES.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. The St. Bernard Parish Council hereby amend Chapter 13; Occupational License, Taxes And Regulations, Article II; Fairs, Bazaars and Outdoor shows to add Section 13-27; Permit Requirements for Outdoor Music Events to the St. Bernard Parish Code of Ordinances. Said section shall read:

Sec. 13-27. - Permit requirements for outdoor music event.

(a) Definition. Outdoor music event shall mean and apply to a special event in which entertainment, music or a band is present on the public right-of-way, street or outdoors and open to the public.

(b) Permit requirements. The requirements set forth in chapter 13 subsections 20 and 21 shall apply to a special event permit for an outdoor music event. In addition to those requirements an outdoor music event shall have the following permit requirements:

1. Obtaining a sound permit per 11-134;
2. No Permit for Outdoor music shall be issued for an establishment in a residential zone;
3. No outdoor music event shall continue past 10:00 p.m., with the exception of New Year's Eve. On New Year's Eve, the ending time will be no later than 1:00 a.m. The time limitation provided for in this section may be extended by resolution of the St. Bernard Parish Council.

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:


