AN ORDINANCE TO **AMEND ORDINANCE SBPC #1301-05-12**, ORDINANCE TO AMEND CHAPTER 5, BUILDINGS, CONSTRUCTION AND RELATED ACTIVITIES; ARTICLE II COASTAL ZONE MANAGEMENT; SECTION 5-33 OF THE ST. BERNARD PARISH CODE OF ORDINANCES.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. That Chapter 5, Article II, Section 5-33, Duties of the local coastal program advisory committee, Subsection (d) is amended to read the following:

Sec. 5-33 Duties of the Local Coastal Program Advisory Committee

- (d) Be organized by the local administrator who functions as a non-voting chair of the committee meetings;
- (e) Advise, comment, or make recommendations to the parish council on any coastal project, coastal activity or coastal development;
- (f) Review and comment upon any proposed rules and regulations impacting the coastal zone;
- (g) Recommend to the parish council any modifications to this article;
- (h) Review and comment upon any coastal use permit at the request of the local administrator;
- (i) Nominate a representative to hear appeals in accord with this article;

SECTION 2. Effective Date. This ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto this ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion of this Ordinance with the invalid portions omitted.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:




