

Executive Summary

Pedigo Enterprises, LLC is responding to the Request for Proposal (RFP) released by the St. Bernard Parish Government (SBPG) for Grass Cutting Services. Proposals are being solicited from experienced firms to contract with SBPG to provide the following services for approximately 8 miles of center and side medians as listed in the RFP for St. Bernard Parish Government. All information in this proposal will be valid for a time period of ninety (90) days from the date of submission, which is December 1, 2016.

Pedigo Enterprises has been active in maintenance and revitalization efforts in the New Orleans area, primarily St. Bernard Parish, since 2008 through contracts with other organizations. Our firm desires to continue to provide grass cutting and property maintenance services in St. Bernard Parish and believes contracting directly with SBPG will be the most beneficial and effective working arrangement for both parties.

Pedigo Enterprises, LLC was incorporated in May, 2008 in the state of Louisiana as a Limited Liability Corporation. The business is a Women's Business Enterprise with Melissa A. Pedigo having 100% ownership. Ron Pedigo is designated the primary contact for Pedigo Enterprises for purposes of this RFP. I. Minimum Qualifications:

Pedigo Enterprises, LLC meets the minimum qualifications for eligible contractors that St. Bernard Parish Government has identified. Pedigo Enterprises, LLC has prior and current “experience in effectively managing and tracking grass cutting contracts in multiple locations” and currently “demonstrates adequate capacity to cut grass, maintain a schedule/tracking system, and report any deficiencies” on properties maintained for SBPG.

We are currently contracted to provide routine maintenance cuts (RMC) for 131 properties in St. Bernard Parish – Zone G as a contractor to St. Bernard Parish Government. Our performance includes between 20-22 routine maintenance cuts per year for the past three years. Responsibilities for routine maintenance cuts include the following:

- Effectively scheduling and tracking work to ensure the most efficient use of time and resources
- Lawn cutting
- Edging of slab outlines
- Trimming and weed-eating perimeter of property
- Blowing all grass debris off all hard-surface surroundings (driveways, sidewalks, etc.)
- Documenting work completed through taking and uploading pictures taken each cycle
- Debris removal and trash/litter pick up on all properties
- Daily communication on property maintenance services completed and assessing status of individual properties for reporting purposes
- Identifying deficiencies and ongoing maintenance needs
- Performing quality control oversight and on-the-job training for employees
- Maintaining good rapport and working relationships with local residents and other commercial operations in the neighborhoods
- Hiring and maintaining the employee work force needed to accomplish all tasks on a timely basis with a quality outcome.

In addition, we have provided initial clean up (ICU) services for hundreds of new turnover properties to prepare for routine maintenance. Hazardous waste items which require special handling and disposal are moved from the property and put at the curb for St. Bernard Parish to dispose of properly. This includes items such as asbestos, tires, oil, paint, and old refrigerators which cannot be disposed of at the regular parish dump site. Once all obstacles and hazards are removed, the property is cut, edged, trimmed, and raked. Clippings are removed. Hardscapes are blown free of cut and trim debris.

Pedigo Enterprises clearly demonstrates the experience, capability, and capacity to meet the minimum qualifications to be an eligible contractor for the SBPG Grass Cutting Services

contract. We are sufficiently equipped and staffed to accomplish the Scope of Work to be performed in Exhibit A of the RFP including cutting grass, maintaining a schedule/tracking system, and reporting any deficiencies on the adjudicated properties.

II. Evaluation Criteria:

a. Contractor's experience and qualifications of personnel assigned to the management of the contract.

Pedigo Enterprises began grass cutting and grounds maintenance services in April 2002. We are now in our 14th year of operation. From 2002 to 2008 the company operated as R&M Grounds Maintenance and provided regular lawn care, landscaping, and other grounds maintenance services for commercial and residential properties primarily in East Baton Rouge and Ascension Parishes. R&M Grounds Maintenance became a subsidiary of Pedigo Enterprises upon incorporation in 2008. Since 2008, the majority of the operation of Pedigo Enterprises has been to provide property maintenance services in St. Bernard Parish as a subcontractor to several other operations.

The key staff person for the SBPG contract will be Ron Pedigo. He will be assigned 100% to the project for the duration of the contract. Ron maintains a residence in Meraux, Louisiana and will be on the job site every day. He will provide direct supervision of the operation to assure that all contractual requirements are met. As Ron's resume (Attachment A) indicates, he has extensive experience in commercial and residential property maintenance. In addition, he has experience as a mechanic of vehicles, residential lawn equipment, and commercial grounds-keeping equipment. Ron is an ASE-certified mechanic. His experience and abilities in maintenance and repair enables him to keep equipment operational and in good working condition which is essential to timely completion of assignments.

The owner, Melissa Pedigo, currently handles the administrative and office responsibilities for Pedigo Enterprises. She provides assistance to SBPG in various aspects of the field operation including tracking, picture-taking, and reporting work completed required by the SBPG contract. Melissa will provide administrative oversight for the duration of the contract with SBPG and will be onsite on an as-needed basis. Melissa's resume of experience relative to the SBPG contract is included as Attachment B.

Melissa and Ron Pedigo are the key staff for the SBPG contract with Melissa handling administrative oversight and Ron having responsibility for supervising the daily operation. Pedigo Enterprises currently has seven regular field employees onsite who perform property maintenance tasks.

b. Capacity to effectively manage and maintain (grass cutting services) of a large number of properties.

Pedigo Enterprises has demonstrated the capacity to effectively manage and maintain a large number of properties in accordance with contract standards and time frames. We have also realigned our resources as needed to assist other entities in meeting their contractual requirements for properties in St. Bernard Parish, Orleans Parish, and elsewhere. Since 2008 Pedigo Enterprises has provided routine maintenance grass cutting services for an average of 500-700 properties per cut cycle demonstrating we are capable of meeting and exceeding the RFP requirement of maintaining the adjudicated properties in St. Bernard Parish.

Currently our equipment includes seven commercial mowers, fourteen weed-eaters, and five blowers which easily provide us the capacity to cut the required list of adjudicated properties. However, we do not currently use all pieces of equipment simultaneously in our daily operation. We maintain equipment in reserve so we can remain productive even when equipment breakdowns occur. Additional field workers will be hired to maximize the equipment utilization to increase our daily cut capacity. We will ensure all SBPG requirements are met in our hiring procedures as personnel are added or replaced.

c. Management approach to site control, grass cutting services/tracking and reporting any deficiencies on property.

Properties will be managed and tracked through the use of an Excel master spreadsheet. All assigned tracking information for the adjudicated properties and other pertinent information will be maintained on the spreadsheet.

With the many features of the Excel software, all management and reporting functions will be accomplished and available on a broad or narrow scale. The spreadsheet will allow us to sort and select data by street or area to plan and track cuts in a logical and efficient sequence based on location. This will also allow us to distribute the daily workload to ensure timely completion of work.

Every step of the process in a cut cycle can be tracked. Deficiencies, such as downed trees and other debris can be noted as well as the date the deficiency was reported to SBPG for resolution. The following information will be included in the master work spreadsheet:

- Actual Cut Date
- Date Invoice Submitted
- Invoice Number
- Deficiencies Noted, If Any

- Date Deficiencies Reported
- Special Comments

Pedigo Enterprises will provide all required documentation and paperwork for processing by SBPG. Pay requests will be submitted to SBPG with the required documentation on the 1st and 15th of each month. SBPG will inspect work on properties prior to processing a pay request.

Should the need for Change Orders to the previously written maintenance plan for a property develop, Pedigo Enterprises will submit recommendations to SBPG. The work will proceed once the Change Order is approved by SBPG and a Notice to Proceed is issued. Time frame for payment is 60-90 days.

d. Past performance on contracts of a similar nature.

Pedigo Enterprises has established a reputation for completing property maintenance assignments in St. Bernard Parish in a timely manner and with quality results. We strive to be proactive in the effort to revitalize the neighborhoods, support current residents, and encourage potential residents to return to the community. e. Proposed fee structure for grass cutting services as outlined in Exhibit A Scope of Work.

Pedigo Enterprises recognizes the desire of SBPG is to maintain an aesthetically pleasing community environment at the most cost-efficient level of service. As such, our recommendation is to maintain the adjudicated properties with routine maintenance cuts once the property reaches the 12" height requirements. In our experience this is the baseline is required to keep adjudicated properties in compliance with the parish's city ordinance rule of maintaining grass at a height of no more than twelve (12) inches without incurring a fine.

Pedigo Enterprises will establish an as needed cut schedule that will maintain properties in good condition in the most cost-effective manner. Prices shown in the cost information tables below are valid for 90 days after the RFP deadline of December 1, 2016. These prices include removal of normal yard debris and litter per property. Debris created by documented tornados, hurricanes, floods, or other devastating natural disasters is not included.

Our primary bid in response to SBPG's RFP for Grass Cutting is an as needed routine maintenance cut (RMC) to be the most efficient schedule to maintain properties in the condition desired by St. Bernard Parish to maintain an aesthetically pleasing environment conducive to stimulating community growth. Pedigo Enterprises desires to demonstrate our flexibility to best meet the needs of St. Bernard Parish Government's Grass Cutting Services Program and budget.
