On motion of Mr. Luna, seconded by Mr. McCloskey, it was moved to **adopt** the following resolution:

## RESOLUTION SBPC #1608-07-16

A RESOLUTION AUTHORIZING ACCEPTANCE OF A GRANT AWARD FROM THE FY2015-2016 LOUISIANA LOCAL GOVERNMENT ASSISTANCE PROGRAM IN THE AMOUNT OF \$103,800.00 FOR ANIMAL CONTROL CENTER IMPROVEMENTS.

**WHEREAS**, the FY 2016 Louisiana Local Government Assistance Program (LGAP) is a State of Louisiana program designed to provide financial assistance in support of projects which improve the health, safety and quality of life of the residents in selected geographical areas; and

**WHEREAS**, St. Bernard Parish submitted an application to this program in January seeking grant funding to provide new equipment and improvements for St. Bernard Parish Animal Control including a new kennel truck for rescues, repairs due to an existing mold problem, establishment of a cattery, and a puppy isolation area among other projects; and

**WHEREAS**, the State of Louisiana has selected St. Bernard's application for funding under FY16 LGAP program.

**NOW THEREFORE BE IT RESOLVED** that the St. Bernard Parish Council, does hereby authorize the acceptance of a FY2016 grant from the Louisiana Local Government Assistance Program in the amount of \$103,800.00 for Animal Control Center Improvements (a state grant program; 100% funding with no local match required); and

**BE IT FURTHER RESOLVED**, the St. Bernard Parish Council does hereby authorize the President of St. Bernard Parish Government to sign and submit all required grant agreements, Cooperative Endeavor Agreements and any amendments thereof, and all of the necessary reports, assurances, contracts and any other documents required in connection with the LGAP Program.
