WHEREAS, St. Bernard Parish Government, as a Louisiana coastal parish, endeavors to utilize and preserve its coastal natural resources to the fullest extent possible, and;

WHEREAS, it is desirous for St. Bernard Parish Government to utilize and preserve its coastal natural resources for the benefit of its citizens and local economy, and;

**COOPERATIVE ENDEAVOR AGREEMENT
BETWEEN ST. BERNARD PARISH GOVERNMENT
AND
THE SAVE LOUISIANA COALITION, INC**

WHEREAS St. Bernard Parish Government, as a Louisiana coastal parish, endeavors to utilize and preserve its coastal natural resources to the fullest extent possible, and;

WHEREAS it is desirous for St. Bernard Parish Government to utilize and preserve its coastal natural resources for the benefit of its citizens and local economy, and;

WHEREAS the Save Louisiana Coalition, Inc, has been formed by citizens as a non-profit organization engaged in the protection of all of Louisiana's coastal resources and the communities/constituencies that utilize and/or are served by them.

NOW THEREFORE BE IT AGREED that the following Cooperative Endeavor Agreement shall be enacted by and between St. Bernard Parish Government and the Save Louisiana Coalition, INC.

AGREEMENTS

The Save Louisiana Coalition, INC (SLC) and St. Bernard Parish Government (SBPG) hereby enter into this Cooperative Endeavor Agreement, which authorizes SLC to assist SBPG in coastal planning, resource protection and public education as a coastal planning body.

SLC shall be authorized to speak on behalf of SBPG with regard to coastal issues, with any accompanying resolution so passed by the governing authority.

SLC shall utilize its own resources, to the extent possible, to assist SBPG in the marketing and economic development of its coastal areas and resources, at no cost to SBPG.

SLC agrees to assist SBPG, to the extent possible, in educating the public with regard to its position on coastal restoration, protection and resources.

SLC agrees, to the extent possible, to assist SBPG in gathering and disseminating information involving coastal projects/legislation at the federal, state and local level, which may affect SBPG.

SLC shall not be authorized to indebt SBPG in any manner without expressed written authorization passed legislatively by the St. Bernard Parish Council.

This agreement shall remain in effect until such time that either SBPG or SLC serve written notice to the other of any intent to dissolve the agreement. There shall be a 30-day notice given for intent to dissolve this agreement. For purposes of this Cooperative Endeavor Agreement a resolution passed by the governing body of the organization shall serve as written notice given for the intent to dissolve. Any amendments to this agreement shall be agreed upon via resolution by both SBPG and SLC.
