A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO ENTER INTO A SUB-RECIPIENT AGREEMENT BETWEEN ST. BERNARD PARISH GOVERNMENT AND NUNEZ COMMUNITY COLLEGE FOR USE OF CDBG-DISASTER RECOVERY LONG TERM COMMUNITY RECOVERY PROGRAM FOR WORKFORCE DEVELOPMENT

WHEREAS, the St. Bernard Parish Government has been afforded the opportunity to apply and participate as a Grantee in the State of Louisiana Community Development Block Grant - Disaster Recovery Program administered by the Division of Administration (STATE); and,

WHEREAS, the STATE requires Grantees to establish sub-recipient agreements with entities within the parish participating in the Disaster Recovery Parish Program through the St. Bernard Parish Government to ensure compliance with the Community Development Block Grant Program (CDBG); and,

WHEREAS, Nunez Community College is participating with the St. Bernard Parish Government in the implementation of a Work Force Development Project of which \$500,000.00 of CDBG Long Term Community Recovery Program is being used as the financing.

NOW THEREFORE BE IT RESOLVED, by the St. Bernard Parish Council, that the attached Sub-Recipient Agreement, dated the 7th day of February 2014, is hereby adopted, affirmed and the President of the St. Bernard Parish Government is authorized to execute any and all documents related to this sub recipient agreement.
