EXTRACT OF THE OFFICIAL PROCEEDINGS OF THE COUNCIL OF THE PARISH OF ST. BERNARD, STATE OF LOUISIANA, TAKEN AT A REGULAR MEETING HELD IN THE COUNCIL CHAMBERS OF THE ST. BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, APRIL 15, 2014 AT THREE O'CLOCK P.M.

On motion of Mr. Montelongo, seconded by Mr. Lauga, it was moved to **adopt** the following resolution:

RESOLUTION SBPC #1154-04-14

A RESOLUTION AUTHORIZING THE PARISH PRESIDENT OF ST. BERNARD PARISH TO ENTER INTO AN AGREEMENT WITH THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT, TO PROVIDE FOR THE INSTALLATION OF ROADWAY LIGHTING ON W. JUDGE PEREZ DRIVE, CHALMETTE, LA AT THE ENTRANCE OF ST. BERNARD PARISH HOSPITAL, TO ASSUME ALL MAINTENANCE AND OPERATING COST, OF THE SUBJECT LIGHTING SYSTEM.

WHEREAS, the Louisiana Department of Transportation and Development will provide for the installation of roadway lighting near 8000 W. Judge Perez Drive, Chalmette, LA; and,

WHEREAS, prior to installation of said lighting system, the Parish of St. Bernard must enter into an agreement with the Louisiana Department of Transportation and Development which obligates the Parish to assume all maintenance and energy cost, of said roadway lighting system; and

WHEREAS, in order to proceed with the design of said roadway lighting system, the Louisiana Department of Transportation and Development requires that the governing authority authorize the Parish President to execute the subject agreement on behalf of the Parish of St. Bernard.

SECTION 1. The Council of the Parish of St. Bernard, that the Parish President is hereby authorized to execute on behalf of the Parish of St. Bernard, an agreement with the Louisiana Department of Transportation and Development which obligates the Parish of St. Bernard to assume all maintenance and operating cost, of the subject roadway lighting system.

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the
