A RESOLUTION SUPPORTING THE EFFORTS OF ADMINISTRATION TO MODIFY THE HOME MORTGAGE AUTHORITY'S RULES AND REGULATIONS REGARDING FINANCING AVAILABILITY.

WHEREAS, the Council and Administration believe that it is in the best interests of the citizens of St. Bernard Parish that the St. Bernard Parish Home Mortgage Authority (hereinafter "the Home Mortgage Authority") amends its provisions with regards to financing availability;

WHEREAS, the Council and Administration believe that it is in the best interests of the citizens of St. Bernard Parish to encourage the construction of new houses in St. Bernard Parish;

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby support the efforts of the Administration to assist the Home Mortgage Authority in obtaining all necessary governmental approvals to allow it to modify the financing availability provisions of the Home Mortgage Authority to include programs that would allow it to lend funds to approved contractors for the construction of new houses.


The Council Chair, Mr. McInnis, cast his vote as **YEA**.
