On motion of Mr. Hunnicutt, seconded by Mr. Lewis, it was moved to **adopt** the following resolution:

RESOLUTION SBPC #1166-05-14

A RESOLUTION SUPPORTING THE EFFORTS OF STATE REPRESENTATIVE RAYMOND E. GAROFALO, JR. IN ADOPTING LOUISIANA REVISED STATUTE 13:2575.6.

WHEREAS, the St. Bernard Parish Council decrees that it is in the best interest of St. Bernard Parish that the jurisdiction of future Hearing Officers be increased;

WHEREAS, the St. Bernard Parish Council decrees that the current system of enforcement does not fully protect the rights of the citizens, nor does it fully enforce the laws passed by this body,

WHEREAS, the St. Bernard Parish Council decrees that LSA R.S. 13:2575.6, as worded below, shall create a larger jurisdiction of the Hearing Officer.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby support State Representative Raymond E. Garofalo, Jr. to adopt Louisiana Revised Statute 13:2575.6

Additional administrative adjudication procedures in St. Bernard Parish

A. In the parish of St. Bernard, the term "housing violation" as used in this Chapter shall also encompass building codes, zoning, vegetation, and nuisance ordinances.

B. In the parish of St. Bernard, the procedures for administrative adjudication provided in this Chapter may also be utilized in matters involving licensing and permits and any other ordinance violation.
