A RESOLUTION GRANTING AUTHORITY TO THE PARISH PRESIDENT TO EXECUTE NECESSARY DOCUMENTS FOR THE LOUISIANA COMMUNITY DEVELOPMENT BLOCK GRANT DISASTER RECOVERY PROGRAM'S PARISH RECOVERY PLANNING CAPACITY BUILDING PROGRAM.

WHEREAS, the Louisiana Office of Community Development has made available funding to St. Bernard Parish in the amount of \$182,700.00 through the Louisiana Community Development Block Grant Disaster Recovery Program's Parish Recovery Planning Capacity Building Program; and,

WHEREAS, the purpose of this program is to allow St. Bernard Parish Community Development Department to hire a professional urban and regional planner for a three-year period to assist with implementing disaster recovery projects and programs; and

WHEREAS, this federal grant program which is administered by the Louisiana Division of Administration, Office of Community Development involves filing applications along with a significant amount of documentation and reporting relative to the implementation of the Parish Recovery Planning Capacity Building Program; and

WHEREAS, this program requires St. Bernard Parish Government to authorize execution of the proper grant documents.

NOW THEREFORE BE IT RESOLVED, that the St. Bernard Parish Council, does hereby authorize the President of St. Bernard Parish Government to sign and submit all required applications, Cooperative Endeavor Agreements and any amendments thereof, and all of the necessary reports, assurances, contracts and any other documents required in connection with the Community Development
