RESOLUTION SBPC #1185-06-14

A RESOLUTION DIRECTING PARISH ADMINISTRATION TO ONLY PRESENT COUNCIL WITH PROPERTIES DUE FOR IMMEDIATE ORDER OF DEMOLITION AS UNSAFE STRUCTURES PER STATE LAW.

WHEREAS, the Legal Department has advised the Council that Administration has the legal ability without Council to remove homes from the demolition list and/or to sign the Standard Agreement with the home owners to allow time to renovate said properties, and;

WHEREAS, the Council is desirous to be presented only with properties that are due for immediate order of demolition as unsafe structures per State Law.

THEREFORE BE IT RESOLVED, the St. Bernard Parish Council, the Governing Authority for St. Bernard Parish, does hereby direct Parish Administration to only present Council with properties due for immediate order of demolition as unsafe structures per state law.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:
