On motion of Mr. Guy, seconded by Mr. Lewis, it was moved to **adopt** the following resolution.

A RESOLUTION APPROVING CONTINGENCY LOCAL MATCH FUNDING TOWARDS HURRICANE ISAAC GRANTS UNDER THE COMMUNITY DEVELOPMENT BLOCK GRANT DISASTER RECOVERY PROGRAM AND FEMA HAZARD MITIGATION GRANT PROGRAM IN THE AMOUNT OF \$546,432.00 TO SUPPORT THE ST. BERNARD PARISH RAW WATER INTAKE BRIDGE PROJECT IN THE EVENT THAT OUTSIDE FUNDING SOURCES DO NOT MATERIALIZE.

WHEREAS, the Parish applied in October, 2013 for a grant under the Hurricane Isaac Hazard Mitigation Grant Program in the amount of \$1,455,610.00 to help fund approximately 75% of the Raw Water Intake Bridge Project which has a total cost of \$2,152,042.00 and would require a local match of \$696,432.00; and,

WHEREAS, the Parish is pursuing funding of this same project from the Federal Emergency Management Agency under the Hurricane Katrina Disaster Recovery Program (with 100% funding) but has yet to receive such funding; and,

WHEREAS, the Office of Community Development has made available funding in the amount of \$150,000.00 through the Louisiana Community Development Block Grant Disaster Recovery Program to assist St. Bernard Parish, impacted by Hurricane Isaac, in implementing ongoing and planned recovery projects; and,

WHEREAS, the Parish submitted an application to utilize this \$150,000.00 in funding in May, 2014 and passed a resolution declaring this an urgent need on May 6, 2014; and,

WHEREAS, the Office of Community Development requires that St. Bernard Parish Council acknowledge it is committed to providing the remaining local
