RESOLUTION SBPC #1226-09-14

A RESOLUTION SUPPORTING THE EFFORTS OF STATE REPRESENTATIVE RAYMOND E. GAROFALO, JR. IN ADOPTING LOUISIANA REVISED STATUTE 33:1243(A)(3).

WHEREAS, the St. Bernard Parish Council decrees that it is in the best interest of St. Bernard Parish that the maximum fines for violation of the St. Bernard Parish Code of Ordinances be increased; and,

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby support State Representative Raymond E. Garofalo, Jr. to adopt Louisiana Revised Statute 33:1243(A)(3):

(3) Notwithstanding the provisions of Paragraph (1) of this Subsection or any other law to the contrary, in the parish of St. Bernard, the maximum penalty which may be imposed for violation of any parish ordinance shall be a fine of one thousand five hundred dollars (\$1,500.00) and/or imprisonment of six months in the parish jail.
