BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, OCTOBER 7, 2014 AT SEVEN O'CLOCK P.M.

On motion of Mr. Lauga, seconded by Mr. Gorbaty, it was moved to **adopt** the following resolution:

RESOLUTION SBPC #1235-10-14

A RESOLUTION AUTHORIZING THE PARISH TO PAY MIKE MUNNA L.L.C. FOR OUTSTANDING INVOICES RELATING TO DEMOLITION/DEBRIS REMOVAL SERVICES IN THE AFTERMATH OF HURRICANE KATRINA.

WHEREAS, the St. Bernard Parish Council decrees that it is in the best interest of St. Bernard Parish that contractors be fully compensated for work done for the benefit of St. Bernard Parish in the aftermath of Hurricane Katrina; and,

WHEREAS, Mike Munna L.L.C. performed demolition/debris removal services throughout St. Bernard Parish as a sub-contractor for Unified Recovery Group ("URG") in the aftermath of Hurricane Katrina; and,

WHEREAS, SBPG's contract with URG provides that SBPG has the right to withhold payment to URG for nonpayment of sub-contractors; and,

WHEREAS, URG has failed to compensate Mike Munna L.L.C. for the demolition/debris removal services it performed in the aftermath of Hurricane Katrina.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the Governing Authority of St. Bernard Parish, does hereby approve and authorize the parish to pay Mike Munna L.L.C. the sum of Thirty Two Thousand Four Hundred Fifty Two Dollars and Eighty Three Cents (\$32,452.83) for Hurricane Katrina Related Demolition/Debris Removal. To be paid from unobligated general funds and to be sought for reimbursement through legal recourses of the primary contractor.
