## **RESOLUTION SBPC #1241-10-14**

A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO SUBMIT A GRANT APPLICATION TO THE LOUISIANA OFFICE OF COMMUNITY DEVELOPMENT (DIVISION OF ADMINISTRATION) FOR THE PURPOSE OF SECURING \$50,000.00 FROM THE 2013-2014 LOUISIANA GOVERNMENTAL ASSISTANCE PROGRAM TO ACQUIRE COMPUTER EQUIPMENT FOR SAINT BERNARD PARISH GOVERNMENT OPERATIONS.

WHEREAS, Saint Bernard Parish Government seeks to secure funding from the 2013-2014 Louisiana Governmental Assistance Program to acquire computer equipment for St. Bernard Parish Government operations, and;

WHEREAS, the acquisition of new computer equipment will enhance the local government's capacity to efficiently serve the public, and;

WHEREAS, the Executive Finance Committee recommended approval on October 16, 2014; and

WHEREAS, the Governing Authority desires to apply for funds from the 2013-2014 Louisiana Governmental Assistance Program for the aforementioned purposes.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority, does hereby authorize the Parish President to submit a grant application to the Louisiana Office of Community Development (Division of Administration) for the purpose of securing \$50,000.00 from the 2013-2014 Louisiana Governmental Assistance Program to acquire computer equipment for Saint Bernard Parish Government operations.
