On motion of Mr. Lewis, seconded by Mr. Gorbaty, it was moved to **adopt** the following resolution:

RESOLUTION SBPC #1243-11-14

A RESOLUTION SUPPORTING THE INDUSTRIAL GROWTH BY ENCOURAGING THE LOUISIANA PUBLIC SERVICE COMMISSION TO ACT TIMELY WHEN ENTERGY'S LOUISIANA COMPANIES MAKE REQUESTS FOR APPROVAL OF THE GENERATION SUPPLY PLAN.

WHEREAS, the state of Louisiana is projected to experience a lot of economic development growth between 2015 and 2019; and,

WHEREAS, historic growth opportunities are within Louisiana's grasp; and,

WHEREAS, in order to meet the energy demand for that growth, Entergy will need more generating capacity; and,

WHEREAS, delays in adding new generating capacity will be costly, not just in dollars lost, but in growth potential lost for Louisiana's economy and its communities; and,

WHEREAS, Entergy wants to collaborate with the Louisiana Public Service Commission to enhance the way these projects are approved.

THEREFOR BE IT RESOLVED, the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby support the industrial growth by encouraging the Louisiana Public Service Commission to act timely when Entergy's Louisiana companies make requests for approval of the addition of new generation and transmission.
