On motion of Mr. Gorbaty, seconded by Mr. Hunnicutt, it was moved to **adopt** the following resolution:

## RESOLUTION SBPC #1258-12-14

A RESOLUTION TO HIRE ADMINISTRATIVE PERSONNEL FOR THE FIRE DEPARTMENT, HOUSING REDEVELOPMENT, AND DISTRICT ATTORNEY OFFICE.

**WHEREAS**, the St. Bernard Parish Council passed **SBPC #1565-10-14** instituting a moratorium on all new hires, except those approved by council by a 2/3 vote of the entire membership.

**NOW THEREFORE, BE IT RESOLVED**, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby allow the hiring of four (4) Firefighters for the Department of Fire, one (1) accountant for Housing Redevelopment and a total of eighteen (18) positions for the District Attorney Office. The District Attorney Office positions will consist of one (1) District Attorney, seven (7) Secretaries, one (1) Law Clerk, eight (8) Assistant District Attorneys, and one (1) Office Manager.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:

The Chairman, Mr. McInnis, cast his vote as **YEA**.
