## **RESOLUTION SBPC #1269-12-14**

A RESOLUTION REQUESTING THE LOUISIANA SECRETARY OF STATE TO CANVAS AND PURGE ALL INACTIVE VOTERS FROM THE ST. BERNARD PARISH VOTER ROLL.

**WHEREAS**, St. Bernard Parish Council supports the efforts of the Councilman Nathan Gorbaty in eliminating inactive voters from the voter rolls.

**NOW THEREFORE, BE IT RESOLVED**, the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby authorize councilmen Nathan Gorbaty to negotiate with the Louisiana Secretary of State to eliminate inactive voters from the St. Bernard Parish voter rolls.

**SECTION 1. Severability.** If any section, clause, paragraph, provision or portion of this resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this resolution, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.

The above and foregoing having been submitted to a vote, the vote there upon resulted as follows:
