On motion of Mr. Lewis, seconded by Mr. Gorbaty, it was moved to **table** the following resolution until the price of the GIS mapping costs are complete:

RESOLUTION SBPC #1283-01-15

A RESOLUTION REQUESTING APPROVAL TO RENAME A DEDICATION FROM THE FIFTY MILLION DOLLAR BOND FROM "GIS MAPPING" TO "GIS MAPPING/MASTER DRAINAGE PLAN."

NOW THEREFORE, BE IT RESOLVED,

SECTION 1. That the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby approve the change in name of "GIS MAPPING" to "GIS Mapping/Master Drainage Plan." The change in name shall allow the administration to spend the nine hundred thousand dollar (\$900,000) dedication to "GIS MAPPING" on the "Master Drainage Plan."

SECTION 2. Severability. If any section, clause, paragraph, provision or portion of this resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this resolution, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this resolution with the invalid portions omitted.
