## RESOLUTION SBPC #1291-02-15

A RESOLUTION TO HIRE ADMINISTRATIVE PERSONNEL FOR THE HOUSING DEPARTMENT, CABLE DEPARTMENT, WATER AND SEWER DEPARTMENT AND TOURISM DEPARTMENT.

**WHEREAS**, the St. Bernard Parish Council passed **ORDINANCE SBPC #1565-10-14** instituting a moratorium on all new hires, except those approved by council by a 2/3 vote of the entire membership.

**NOW THEREFORE, BE IT RESOLVED**, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby allow the hiring of Receptionist and a HCV Specialist for the Housing Department, an assistant to the Film Director in the Cable Department, two meter reader positions in the Water and Sewer Department and an Aycock Barn Farmers Market Coordinator in the Tourism Department.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:
