## **RESOLUTION SBPC #1297-02-15**

A RESOLUTION TO AUTHORIZE A PAY INCREASE FOR ADMINISTRATIVE EMPLOYEES IN THE WATER AND SEWER DEPARTMENT.

**WHEREAS**, the St. Bernard Parish Council passed **ORDINANCE SBPC #1566-10-14** instituting a temporary moratorium and review on all salary increases for St. Bernard Parish Government employees, except those approved by council by a 2/3 vote of the entire membership.

**NOW THEREFORE, BE IT RESOLVED**, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby authorize the following pay increases for administrative employees in the water and sewer department.

- Accounting Clerk II - Increase Salary from \$27,206 to \$28,206
- Accounting Clerk II - Increase Salary from \$25,433 to \$26,433

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:
