A RESOLUTION TO HIRE ADMINISTRATIVE PERSONNEL FOR THE WATER AND SEWER DEPARTMENT, FINANCE DEPARTMENT AND ANIMAL CONTROL DEPARTMENT.

WHEREAS, the St. Bernard Parish Council passed **ORDINANCE SBPC #1565-10-14** instituting a moratorium on all new hires, except those approved by council by a 2/3 vote of the entire membership.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby allow the hiring of an Accounting Clerk II and a Plant Operator I in the Water and Sewer Department, a Recovery Clerk in the Finance Department and a Kennel Worker in the Animal Control Department.
