## RESOLUTION SBPC #1310-03-15

A RESOLUTION TO AUTHORIZE A PAY INCREASE FOR A FINANCIAL ANALYST IN THE CDBG/RECOVERY DEPARTMENT.

**WHEREAS**, the St. Bernard Parish Council passed **ORDINANCE SBPC #1566-10-14**, instituting a temporary moratorium and review on all salary increases for St. Bernard Parish Government employees, except those approved by council by a 2/3 vote of the entire membership.

**NOW THEREFORE, BE IT RESOLVED**, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby authorize the following pay increase for a financial analyst in the CDBG/Recovery Department.

- Financial Analyst - Increase Salary from \$37,739 to \$42,500
