A RESOLUTION AUTHORIZING DAVID E. PERALTA, PARISH PRESIDENT TO ENTER INTO THE REQUIRED COOPERATIVE ENDEAVOUR AGREEMENTS WITH THE LA DIVISION OF ADMINISTRATION, OFFICE OF COMMUNITY DEVELOPMENT- DISASTER RECOVERY UNIT TO SECURE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) DISASTER RECOVERY FUNDS; TO UTILIZE THE STATE'S ADMINISTRATIVE CONSULTANT PAN AMERICAN ENGINEERS, INC., TO ADMINISTER THE LONG TERM COMMUNITY RECOVERY AND FISHERIES PROGRAM ON BEHALF OF THE PARISH GOVERNMENT; AND, TO AUTHORIZE THE PARISH PRESIDENT TO SIGN ANY AND ALL DOCUMENTS REQUIRED IN THE SUBMISSION OF THE REQUIRED APPLICATION AND SUBSEQUENT ADMINISTRATION OF THE PROGRAM.

WHEREAS, the St. Bernard Parish Government (SBPG) will submit the required application and/or amendments to the Louisiana division of administration, office of community development- disaster recovery unit to secure its appropriation of CDBG disaster recovery funding; and,

WHEREAS, the "program" shall be defined as any CDBG related Disaster Recovery fund for any past and/or future disasters; and,

WHEREAS, implementation of the program services requires completion of the application and subsequent administration of the grant program in accordance with all CDBG regulations; and,

WHEREAS, submission of the application and subsequent administration of the grant program requires the execution of numerous forms and documents.

SECTION 1. NOW, THEREFORE BE IT RESOLVED by the St. Bernard Parish Council, on behalf of the St. Bernard Parish Government that, David E. Peralta, Parish President be hereby authorized to enter into the required Cooperative Endeavor Agreement with the LA Division of Administration, Office of Community Development- Disaster Recovery Unit to secure long term Community Development Block Grant (CDBG) Disaster Recovery & Fisheries funds and to sign any and all
