A RESOLUTION AUTHORIZING ACCEPTANCE OF A LOUISIANA COMMISSION ON LAW ENFORCEMENT GRANT FOR CRIMINAL JUSTICE SECURITY UPGRADES FOR 34<sup>TH</sup> JUDICIAL DISTRICT COURT IN THE AMOUNT OF \$5,116.00.

**WHEREAS**, the U.S. Department of Justice, Bureau of Justice Assistance under the Edward Byrne/Justice Assistance Grant Program provides funding to local agencies to assist with computer upgrades and other needs; and

**WHEREAS**, this grant program in Louisiana is administered by the Louisiana Commission on Law Enforcement under the Office of the Governor, Louisiana Commission on Law Enforcement and Administration of Criminal Justice; and

**WHEREAS**, St. Bernard Parish Government submitted an application to fund Criminal Justice Security Upgrades for the 34<sup>th</sup> Judicial District Court; and

**WHEREAS**, this grant will be used to fund security cameras for the Magistrate Court of the 34<sup>th</sup> Judicial District; and

**WHEREAS**, St. Bernard Parish's application for Criminal Justice Security Upgrades was selected for full approval in March.

**NOW THEREFORE BE IT RESOLVED**, the St. Bernard Parish Council, does hereby authorize the acceptance of this Louisiana Commission on Law Enforcement Grant for the Criminal Justice Security Upgrades for the 34<sup>th</sup> Judicial District Court Project in the amount of \$5,116.00 grant (no local matching funds required); and
