## **RESOLUTION SBPC #1321-04-15**

A RESOLUTION AUTHORIZING ACCEPTANCE OF A LOUISIANA GOVERNMENT ASSISTANCE PROGRAM GRANT PROGRAM IN THE AMOUNT OF \$82,367.00 FOR LIGHTS AND SECURITY CAMERAS AT SIDNEY TORRES MEMORIAL AND VAL RIESS PARKS.

**WHEREAS**, the FY 2015 Louisiana Local Government Assistance Program (LGAP) is a State of Louisiana program designed to provide financial assistance in support of projects which improve the health, safety and quality of life of the residents in selected geographical areas; and,

**WHEREAS**, St. Bernard Parish applied for a grant under this program to increase lighting and provide security cameras for Torres and Val Riess Parks; and

**WHEREAS**, St. Bernard Parish Council approved the submission of this application at its December 16, 2014 meeting; and,

**WHEREAS**, St. Bernard Parish's grant application was selected for full approval in March.

**NOW THEREFORE BE IT RESOLVED**, the St. Bernard Parish Council does hereby authorize the acceptance of this Louisiana Government Assistance Program Grant for the Lights and Security Cameras at Sidney Torres Memorial and Val Riess Parks in the amount of \$82,367.00 (no local matching funds required); and

**BE IT FURTHER RESOLVED**, the St. Bernard Parish Council, does hereby authorize the President of St. Bernard Parish Government to sign and execute all required grant agreements and any amendments thereof, and all of the necessary reports, assurances, contracts and any other documents required in connection with this Louisiana Government Assistance Grant Program.
