BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, MAY 19, 2015 AT THREE O'CLOCK P.M.

On motion of Mr. McInnis, seconded by Mr. Gorbaty, it was moved to **adopt** the following resolution:

RESOLUTION SBPC #1332-05-15

A RESOLUTION TO AUTHORIZE A PAY INCREASE FOR A DISTRIBUTION OPERATOR IN THE WATER AND SEWER DEPARTMENT, A HVC INTAKE SPECIALIST AND A CLERICAL SPECIALIST IN THE HOUSING DEPARTMENT AND THE ASSISTANT FINANCE DIRECTOR OF AUDITS AND FINANCIALS AND A SENIOR ACCOUNTANT IN THE FINANCE DEPARTMENT.

WHEREAS, the St. Bernard Parish Council passed **ORDINANCE SBPC #1566-10-14**, instituting a temporary moratorium and review on all salary increases for St. Bernard Parish Government employees, except those approved by council by a 2/3 vote of the entire membership.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby authorize the following pay increase for a Distribution Operator in the Water and Sewer Department, a HVC Intake Specialist and a Clerical Specialist in the Housing Department and the Assistant Finance Director of Audits and Financials and a Senior Accountant in the Finance Department.

- Distribution Operator increase salary from \$29,702 to \$35,000
- HVC Intake Specialist increase pay rate from \$12.50/hour to \$13.50/hour
- Clerical Specialist increase pay rate from \$9/hour to \$12.50/hour
- Assistant Finance Director of Audits and Financials increase salary from \$55,000 to \$65,000
- Senior Accountant increase salary from \$49,426 to \$54,426
