A RESOLUTION ACCEPTING THE \$150,000.00 COMMUNITY DEVELOPMENT BLOCK GRANT FOR SUPPORT OF ST. BERNARD COURTHOUSE REPAIRS.

WHEREAS, the Louisiana Office of Community Development has made available funding through the Louisiana Community Development Block Grant (CDBG) Disaster Recovery Program administered by the Division of Administration to assist parishes impacted by Hurricane Isaac in implementing ongoing and planned recovery projects; and,

WHEREAS, in April, 2015, the St. Bernard Parish Council authorized a grant application to be submitted to the Office of Community Development in the amount of \$150,000 for St. Bernard Parish Courthouse Repairs; and,

WHEREAS, the Office of Community Development has approved this grant application.
