RESOLUTION SBPC #1343-06-15

A RESOLUTION REQUESTING FROM THE ATTORNEY GENERAL ANY EVIDENCE OF ETHICS VIOLATIONS, CRIMINAL ACTIVITY, OR VIOLATIONS OF AN EXPRESS PROHIBITION IN THE ST. BERNARD PARISH CHARTER BY ST. BERNARD PARISH PERSONNEL, OFFICERS, AGENTS, OR ELECTED OFFICIALS.

WHEREAS, it is the duty of the St. Bernard Parish council to protect and ensure the personnel of St. Bernard Parish Government do not violate the law or Louisiana Code of Governmental Ethics.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby request from the attorney general any evidence of ethics violations, criminal activity, or violations of an express prohibition in the St. Bernard parish charter by St. Bernard parish personnel, officers, agents, or elected officials.

BE IT FURTHER RESOLVED, that this term shall be effective immediately upon adoption of this Resolution.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:
