RESOLUTION SBPC #1348-06-15

A RESOLUTION REQUESTING THAT LOUISIANA GOVERNOR BOBBY JINDAL VETO LEGISLATION THAT WOULD REDUCE THE LOUISIANA FILM TAX CREDITS.

WHEREAS, presently the Parish of St. Bernard, Louisiana is still in a recovery mode as a result of Hurricanes Katrina , Rita and Isaac, and;

WHEREAS, the Parish of St. Bernard has recently been privileged to host many movie and television productions, and;

WHEREAS, the Parish of St. Bernard as a result of these operations has enjoyed increases in tax revenue and rental fees that has created an infusion of much needed revenue for the Parish of St. Bernard which benefits the citizens of St. Bernard and the State of Louisiana, and;

WHEREAS, if the tax credits are capped as per recently enacted legislation, the likelihood is that St. Bernard Parish would see a reduction in this revenue, if not a complete loss.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council and the Parish President of St. Bernard are requesting that Governor Bobby Jindal veto the recently passed legislation to cap the Film Industry Tax Credits.
