On motion of Mr. Lewis, seconded by Mr. McInnis, it was moved to **remove** the following resolution:

RESOLUTION SBPC #1352-07-15

A RESOLUTION TO FILL TWO VACANT CREWMAN POSITIONS AT A RATE OF \$9 PER HOUR IN THE DEPARTMENT OF WATER AND SEWER.

WHEREAS, the St. Bernard Parish Council passed **ORDINANCE SBPC #1565-10-14** instituting a moratorium on all new hires, except those approved by council by a 2/3 vote of the entire membership.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby allow the hiring of two crewman positions at a rate of \$9 per hour in the Department of Water and Sewer. The vacancies are the result of the resignation of an employee at \$12.24 per hour and the termination of an employee at \$9.36 per hour.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:
