## **RESOLUTION SBPC #1353-07-15**

A RESOLUTION TO FILL A VACANT OPERATOR I POSITION AT \$9 PER HOUR IN THE DEPARTMENT OF WATER AND SEWER.

**WHEREAS**, the St. Bernard Parish Council passed **ORDINANCE SBPC #1565-10-14** instituting a moratorium on all new hires, except those approved by council by a 2/3 vote of the entire membership.

**NOW THEREFORE, BE IT RESOLVED**, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby allow the hiring of an Operator I position at \$9 per hour in the Department of Water and Sewer. This vacancy is the result of the resignation of an employee at \$9 per hour.
