On motion of Mr. Lewis, seconded by Mr. McInnis, it was moved to **remove** the following resolution:

RESOLUTION SBPC #1354-07-15

A RESOLUTION TO FILL A VACANT LABORER POSITION AT A RATE OF \$9 PER HOUR IN THE MAINTENANCE DEPARTMENT.

WHEREAS, the St. Bernard Parish Council passed **ORDINANCE SBPC #1565-10-14** instituting a moratorium on all new hires, except those approved by council by a 2/3 vote of the entire membership.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby allow the hiring of a laborer position at a rate of \$9 per hour in the Maintenance Department. The vacancy is due to the resignation of an employee \$10 per hour.
